Dear Senator Graham,

As I mentioned last week your office is ideally suited to addressing my concerns (notwithstanding your letter dated 2-9-15).

You recently received attention for a "joke" where you stated that you would literally deploy the military to force Congress to do their jobs. I suspect that your statement was more hyperbole than humor but at its core is a sentiment that Congress should do its job. Keep in mind that I have been asking you to "do your job" approximately once a week for the last 3 months with your sole response being a letter falsely denying that you have responsibility for illegal interstate intrusions against citizens of your home state or oversight of the judiciary.

Without a doubt, your duty to check the judiciary and your duty to regulate laws regarding interstate interactions and individual rights is a legitimate core function of your office; much more so than the suspect rhetoric that restoring cuts (of any kind) are a duty (when focus on funding and past levels is wistful at best and not a fundamental duty).

To be clear, please do your job and lead by example...

Again, please aid me in getting a special prosecutor appointed to address attacks on citizens of your state via a corrupt N.C. judiciary with subsequent failures and criminal obstruction within the U.S. Supreme Court.

There needs to be accountability within the Justice System (for judges, prosecutors, police, et cetera).

As I have previously mentioned, I have spent over two and a half years giving courts an ability to correct their own errors and the abuses of lower court judges to no avail (with approximately 100-300 accumulated violations directly related to three members of the judiciary and substantially more violations likely provable with adequate investigations on additional members of the judiciary).

Currently no real process for judicial accountability exists without public and/or political pressure.

-She indicated that the clerk issue is likely administrative not criminal (regardless of the criminal deprivation of rights); i.e. within his discretion to obstruct Due Process.

-She indicated that their Section prosecutes Federal matters; I challenged that they also were responsible for state court violations (which she acknowledged as limited); she recommended that I contact the N.C. Attorney General's Office & I mentioned that I believe that his office is directly involved in corruption of the N.C. Judiciary (as a judge involved in a former complaint was made aware of the complaint but the A.G. made no effort to follow-up on the substance of the initial complaint).

-She indicated that their office doesn't do investigations; I indicated that I had attempted criminal complaints with the F.B.I. and they cut the conversation short without taking the specific allegations (which would likely number in the hundreds).

-She noted that I had a right to submit written materials to their office (and the DOJ for Civil Rights violations).

She would not give a name any or identifier to verify the conversation based on security issues; she said I should reference a call made to their office @ 11:49AM on Friday, 1-16-2015 to identify the conversation (but that it is not logged or recorded).
