I am attempting to initiate criminal complaints against at least three individuals related to the judiciary (2 state court judges and a clerk of the U.S. Supreme Court).

I would also like a general investigation into blatant corruption of the judiciary within N.C. (and subsequent links to the Federal Judiciary).

Effectively no process exists to initiate criminal complaints against the judiciary; the typical response I have received is no response; when I actually got an FBI agent on the telephone, he spent a good part of the approximately one hour conversation explaining how/why the FBI might not investigate (with reference to "the real world"); I doubt that I could convey the substance of the actual violations, which were experienced and documented over a course of 2 1/2 years, within approximately 40 hours of verbal conversation (therefore I am skeptical that the FBI agent captured the essence of my complaint in substantially less than one hour).

I believe that an investigation will reveal a corruption of the judiciary that reaches all the way to the Chief Justice of the U.S. Supreme Court where the concept of "protection of the judiciary" is placed higher than individual rights and fundamental judicial duties; amounting to a criminal conspiracy by judges/courts to avoid accountability for judges, prosecutors/lawyers, and police...

Note how this lack of accountability has recently resulted in numerous protests; with sensitivity to injustice very high in minority communities (and increasing awareness within the general population).

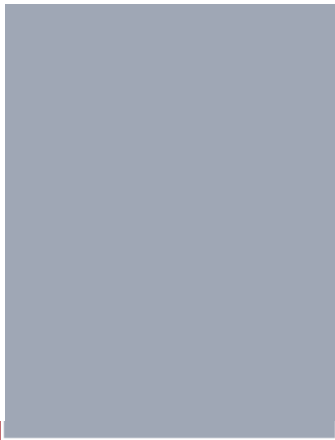
I don't think any citizen opposes holding the Judiciary and the Police accountable to law; correction of injustice is a fundamental duty of every citizen and especially of our elected officials.

I have spent 2 1/2 years attempting to get the judiciary to do their jobs and reform themselves to no avail.

I now petition you to do your job and hold the judiciary accountable. Please aid me in getting a special prosecutor appointed for this investigation.
